PRIVACY POLICY

User Consent

You agree to this Privacy Policy ("**Policy**"), which includes full consent to the actual or possibility of collecting, processing, cross-border transfer and storing of Personal Information, as defined in this Policy, when you sign up for, access, or use the website of the **AVENTUS TECHNOLOGY INDIA PRIVATE LIMITED** accessible at: <u>https://lendplus.in/</u> as well as through its the mobile application (the "**Platform**"), any of its features, processes, functions and its related services (collectively "**Services**").

Scope of Use

This Policy informs you of our policies on your privacy rights regarding our collection, use, storage, processing, disclosure and security of your Personal Information when you use the Platform on any device (including mobile devices). This Policy applies to all Personal Information we process in connection with your relationship with us as a customer or potential customer.

This Policy constitutes a legal agreement between you, as the user of the Platform and the Company, as the owner of the Platform. You must be a natural person, citizen of India, who is at least 18 years of age.

Personal Information Collection

Use of Personal Information

The Personal Information we collect from you will be used to allow us to perform the Services requested from us. We may use your Personal Information to:

Service Providers

We may employ third party companies and individuals to facilitate our Service, to provide the Service on our behalf, to perform services-related actions, to assist us in analyzing how our Service is used, or to assist us in the collection of delinquent accounts.

These third parties have access to your Personal Information only to perform these tasks on our behalf and are obligated not to disclose, use, or store your Personal Information for any other purpose.

Sharing of Personal Information

We may share your Personal Information with third parties, which includes, but is not limited to the following entities:

- a. Affiliates and/or Members of our corporate family direct and indirect subsidiaries, to assist in providing the Services listed in the Platform, to help detect and prevent potentially illegal acts and violations of our policies, and to provide proper data analytics on the use of the Platform, including marketing communications.
